Message from Mayor Ryan Lehman

Welcome to May! May is typically a busy month for the City, now more than ever. It's budget season and the City still needs to create its plan for this next fiscal year, beginning July 1st. We still need your help with the budget, so if you're interested in joining the budget committee, please contact City Hall. The budget this year will be tight, as cities across the country see both increasing costs and declining revenue as a result of the pandemic. Amity is no different, but our last few years of good financial management have given us a bit of a monetary cushion to get through until things recover.

Council Vacancy

The City of Amity is seeking a person to fill position #2 on the Amity City Council. To qualify, you must have lived within the city limits for at least one year and you must be a registered voter. Planning Commission Vacancy

Want to make a difference in your community? There is a vacant position on the Amity Planning Commission. To qualify, you must be a registered voter, preferably also a resident living inside City Limits. Amity Info Corner

Did you know that property owners within Amity are required to maintain certain public spaces within the City? Take sidewalks. Ordinance #622 directs that property owners are responsible for maintaining the public sidewalk on their property! Private property owners are responsible for keeping their sidewalks clear of snow, ice, leaves, and all other obstructions that may be a hazard to a pedestrian. Nor may a property owner obstruct a sidewalk in such a manner that it prohibits a pedestrian's use of the sidewalk. Finally, Ordinance #622 states the City has the right to direct a property owner to repair the sidewalk in on their property if it falls into a state of disrepair.

However, the City recognizes that many of our sidewalks are already in "a state of disrepair." Our City Council has been seeking funding to repair sidewalks around town, instead of passing those costs along to the property owner. This is a long and slow process, as sidewalks are incredibly expensive! State and Federal laws require all new sidewalks be built to a set of exacting engineering standards to include incorporating provisions within the "Americans with Disabilities Act" (ADA). While these are necessary requirements to ensure a sidewalk endures and allows access for all, it is expensive. Even repairing sidewalks require these engineering and ADA standards be met. A city block's length of sidewalk may cost Amity tens-of-thousands of dollars to ensure they are built to standards.

We are working to get the grants and funding to fix our sidewalks. But the City cannot make any promises as to how soon we will obtain the needed funding. Until then, we ask that you help preserve the sidewalks we have by ensuring your property's portion is in good repair and clear of snow, ice, leaves and other obstructions. Thank you.

Water System Flushing

The City of Amity Public Works Department has scheduled our periodic flushing of the water system to occur on May 11, 2021, weather permitting, starting at 8 pm and continuing throughout the night. This process stirs the settled sediment into the flowing water and not all of it is removed through the hydrants. The sediment that is not removed may enter your private water lines and, therefore, we advise you to run your COLD water using the outside faucets or bathtubs ONLY on the morning of May 12, 2021 until it runs clear and to exercise caution when washing laundry to avoid color damage.
