REGULAR MEETING OF THE COUNCIL CITY OF AMITY, OR

Minutes

A Regular Meeting of the City of Amity City Council was held at 7:00 p.m. on Wednesday, April 4, 2018 in the Council Chambers, City Hall, 109 Maddox, Amity, Oregon.

CONSENT AGENDA:

Councilor Walker moved to approve the consent agenda, which consisted of bills from March 2018, minutes from the regular session dated March 7, 2018 and minutes from special session dated March 21, 2018. Councilor Miller seconded the motion. With no discussion, the consent agenda was approved 6-0.

CITIZEN COMMENTS/QUESTIONS:

Erin Rainey from Amity Downtown Improvement Group talked about the daffodil show. She talked about planting some bushes at City Hall. Mayor Cape encouraged DIG to keep up the daffodil show in the future. He also stated that some flower bushes could be planted around the park and maybe around the welcome sign as well. Rainey stated that DIG was trying to put something together for Earth Day.

Heath Cokeley from OAWU presented Public Works Superintendent Gary Mathis with a Water Utilities Rookie Operator of the Year Award.

Mayor Cape read a letter he received, thanking the Council for not allowing Dollar General in town.

Michael Andresen at 10745 SW Bellvue Hwy spoke about getting water service to his property and receiving a water connection outside of the City. He stated that for them to put a well on the property, he would need to move their septic system. City Administrator Hogue told the Council that the City has a resolution stating that any outside service requests are to be applied for and reviewed by the Council. The Andresen's will begin the application process to go before the Water and Sewer Committee on April 18, 2018. Hogue mentioned that a request had been denied back in 2013 because it would jeopardize the City's chance to receive CDBG grants.

- a. Ordinance 652 Amending Section 18 of Ordinance 647- Mayor Cape read the 2nd reading. Councilor van Soolen moved
- <u>b.</u> Ordinance 653- Amending Ordinance 640 to allow an exemption for the keeping of livestock through Council resolution- Mayor Cape declared a conflict of interest
- c. <u>City Administrator Compensation</u>- Councilor Walker moved to increase City Administrator Hogue's salary by 2% with back pay starting from the anniversary date of hire, January 9th, in addition to the 2% cost of living adjustment. Councilor King seconded the motion. With no further discussion, the motion passed 6-0.
- d. <u>Building Valuation Data</u> Councilor Simonson moved to adopt the building valuation data as revised February 2018 as created by the International Code Council to be effective immediately. Councilor van Soolen seconded the motion. With no further discussion, the motion passed 6-0.
- <u>e.</u> Resolution 2018-01 Financing Authorization Councilor Simonson moved to approve resolution 2018-01, authorizing the City Administrator to apply for and accept a rural development loan to complete design and construction of water system improvements for the City of Amity. Councilor van Soolen seconded the motion. With no further discussion, the motion passed 6-0.
- <u>f.</u> Resolution 2018-02 Authorization for Grant Application- Councilor Simonson moved to approve resolution 2018-02, authorizing the City Administrator to submit an application for an Oregon Water Resources Development grant. Councilor King seconded the motion. With no further discussion, the motion passed 6-0.

City Recorder by Jackie Loos: Loos submitted a written report and had nothing to add.
